

small battery powered lights mounted to a board hanging over the corn. The lights gave just enough illumination to see a deer's head and neck as it ate from the feeder. This feeder paired with a scoped Marlin .22 is a deadly combination.

An hour after the shot was heard the outlaws got on their four wheeler and headed toward the levee blacked out. The Captain and I were there to stop them. We interviewed them and went back to the scene of the crime. We found a .22 caliber rifle in the stand, along with a propane heater and several bottles of Mad Dog 20/20. We found blood near the feeder and followed it, but the trail went dry.

The next morning we charged the subjects with numerous hunting violations including hunting deer at night with artificial light. One of the subjects pled guilty and the other wanted a trial. When we went to trial he (under the advice of his attorney) pled guilty. He was sentenced to 60 days in jail and ordered to pay over \$1000 in fines. Although this type of outlawing is not as prolific as it used to be, the fact that these guys were caught sends a message to others. If we can catch them, we can catch you.
